

Speed Measurement Techniques CJSTC Course #1158

The 40 hour FDLE course is designed to provide officers with instruction in the principles and operation of radar and laser instruments. Officers will be required to participate in field exercises to demonstrate an understanding of the practical operation of the speed measurement instruments. The course provides an opportunity for officers to develop specialized skills in radar and laser operations. Officers will be required to pass a practical and written test. There is an attendance policy.

***Recommended that the students bring moving (handheld and or/in car) radars or lasers from your agency.**

Lead Instructor

Captain Glenn Luben (retired) began his Law Enforcement career in 1982 when he joined the U.S. Air Force as a Law Enforcement Specialist. In 1986, he joined the Pinellas County Sheriff's Office. He is a US Military veteran of Operation Desert Shield/Desert Storm, Operation Noble Eagle, and Operation Enduring Freedom. In 2003 he retired as a Senior Non-Commissioned Officer (E8) from the U.S. Air Force Reserves after serving over 21 years of active and reserve service.

Captain Luben currently teaches with the University of North Florida (UNF) Institute of Police Technology and Management (IPTM), the Southeastern Public Safety Institute (SEPSI) and the Multijurisdictional Counterdrug Task Force (MCTFT).
